



**TERMS AND CONTITIONS of HIRE**



It is the responsibility of the hirer to follow these safety instructions to avoid injury, or damage to the equipment. Do not allow crowding, and avoid having smaller and larger users on the inflatable at the same time.

- ❖ This unit has an age limit of 16 years, and a height limit the same as the interior walls. Please ensure no-one over these limits uses the equipment. (If we have informed you that this unit is for children **and** adults, then only the height limit applies.)
- ❖ The person who signs below must ensure that the inflatable is fully supervised at all times by a responsible person who is at least 18 years of age.
- ❖ You must be able to locate First Aid facilities in the event of an accident.
- ❖ A separate accident sheet is provided, and any injury to a participant must be recorded on the sheet, signed by the injured person or their representative, and be notified to the operator.
  
- ❖ In the event of rain or strong wind (force 5, or 19 mph and above) it is strongly recommended that the inflatable is switched off. Prevent the cable, plugs and blower from becoming wet. Wetness and bubbling on the inflatable can be dried with a towel.
- ❖ Ensure that the vent on the side of the blower is kept clear at all times, as leaves, sweet wrappers etc. caught on the blower vent may deflate the castle.
- ❖ No person(s) who are visibly intoxicated through alcohol, drugs or any other intoxicating substance shall be permitted to use any equipment.
- ❖ Adults and Children are not permitted to use the equipment at the same time, except where an adult is accompanying their/a child.
  
- ❖ All shoes, spectacles, badges, jewellery, (i.e. large earrings, necklaces etc.) **MUST** be removed prior to using the equipment.
- ❖ Climbing, hanging, or sitting on the walls is **DANGEROUS** and must **NOT** be allowed.
- ❖ Do **NOT** allow toys or any sharp objects to be taken onto the inflatable, as these may cause injury, and damage the equipment.
- ❖ No party poppers, silly string or face-paints are to be used on the bouncer, as they can cause staining.
- ❖ No food, drink, chewing gum or smoking is permitted on any of the equipment.
- ❖ Ensure that no-one with a history of back or neck problems are allowed on the inflatable.
- ❖ Keep people **OFF** the inflatable during inflation or deflation.
